## Changing a Child Support Order in Your State

**!** The information below applies only to Pennsylvania

### 1. How can I find out if I have a “IV-D” child support case in this state?

Call the Pennsylvania Child Support Helpline at 1-800-932-0211, or contact your county Domestic Relations Section (DRS). Contact information for Pennsylvania’s 67 county DRSs can be found on Pennsylvania’s child support website at [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us) under “Contact My Closest DRS.”

### 2. How can I contact my child support agency?

See above. Contact Pennsylvania’s Child Support Helpline at 1-800-932-0211. County office addresses are included in this packet.

### 3. If I am incarcerated, are there any barriers to having my order changed?

No.

### 4. Do you provide any materials online that I can use to ask for a change to my child support order?

Yes. Either party to a child support case may register respectively as a payor or payee on Pennsylvania’s child support website at [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us). Registering on the website allows individuals to provide new information about their case. The website also allows individuals to begin the process to open a new support case by completing an online questionnaire.

### 5. Do you have any printed materials I could read to learn more about child support for parents who are incarcerated?

No, but inmates in Pennsylvania’s correctional institutions have access to the Pennsylvania’s Child Support Enforcement Incarceration Packet, available at the institutions’ libraries, and included here.

### 6. When can I ask to have my order changed?

Either party to a child support order may request an order modification any time they experience a material change in circumstances such as a change in income (new job, job loss, promotion, reduced hours, etc.); child care expenses; medical coverage; custody; age of the child; incarceration; relocation; disability; death; or, special needs of the child.

### 7. How do I request the change?

To request an order modification, write, call or visit the (DRS) that handles your support case. Ask the DRS for a Petition for Modification form, or register on Pennsylvania’s child support website at [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us) as a payor or payee, and download a copy of the Petition for Modification form. Complete, sign and return the Petition for Modification form to the DRS. That form is included here.

### 8. What is the process after I’ve asked to have my order changed, and how long does it take?

Upon receipt of a completed Petition for Modification form, the DRS will schedule a conference and send a notice indicating the date, time and location to attend to review the facts of the case and discuss the modification request. The notice will indicate what information is necessary to bring to the conference. Parents must attend the conference at the scheduled date, time and location. Incarcerated parents may appear by telephone.

## Changing a Child Support Order in Your State

### 9. Is this process different if the other parent agrees to the change in advance?

Yes. Agreement between both parties may expedite the modification process. Both parties to an order may voluntarily agree to modify the order in writing before a conference officer at the county DRS.

### 10. Does it cost anything to try to have my order changed?

Some counties charge fees for providing certain services. Contact the county DRS that is handling the case to determine if there are any fees for requesting services.

### 11. If I am incarcerated, do I need to do anything else to have my order changed?

Incarcerated parents may appear at the DRS by telephone for the modification conference.

### 12. If I am incarcerated, does my state have any programs to help me with child support?

Yes. Some county DRSs conduct outreach to inmates within correctional institutions. The DRS may modify an existing order to a non-financial obligation or close the support case if the obligor does not have the ability to pay. Modifying an existing order to a non-financial obligation will keep the case open, but will prevent the accrual of arrears. In cases where a parent is to be incarcerated for an extended period of time and the youngest child on an existing order will turn 18 or graduate from high school before the obligor's release, the DRS may choose to close the case.

### 13. Can I get help with child support questions from other sources?

The Pennsylvania Institutional Law Project is a non-profit organization that provides assistance to incarcerated or institutionalized low-income inmates. ### 14. Is there anything else I should know about trying to change my order?

Parents who are or will be incarcerated should contact their DRS as soon as possible so the DRS can determine whether the support case should be modified or closed during imprisonment. The Pennsylvania Child Support Handbook and Frequently Asked Questions are available at [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us) and provide information on the modification process.

Dear Parent:

The Bureau of Child Support Enforcement (BCSE) has created the enclosed ***Pennsylvania Child Support Enforcement Incarceration Packet*** that provides valuable information about your rights and responsibilities regarding your child support case.

The packet contains the following resources:

- ***Pennsylvania Child Support Handbook***, which contains information about establishing paternity, receiving and paying child support, medical support, other legal and child support resources, domestic violence and welfare benefits;
- ***Establishing Paternity*** brochure, which answers questions about the various ways to establish paternity, locating a parent, and genetic testing;
- ***Child Support Information for Incarcerated Parents*** brochure, which addresses child support services and options available to incarcerated parents and how to stay active in your child support case;
- ***Support Order Modification*** brochure, which explains how to ask your county Domestic Relations Section (DRS) to modify your child support order during the time of your sentence;
- ***Petition for Modification of an Existing Order*** (OM-501) form that you can use to begin the modification process;
- Information about Pennsylvania's Institutional Law Project; and,
- Contact information for all the DRSs across the Commonwealth.

We hope you find that this information is useful, encourages you to stay active in your child support case, stay connected to your child, and continue to pay child support.

If you have any questions or concerns not addressed by these resources, or you need help accessing these materials, you may contact the DRS that handles your case directly or seek help from your counselor.



## What will establishing paternity do for my child?

When you establish paternity, your child may be eligible for the following:

- **Birth Certificate** - Your child's birth certificate will show the name of the father.
- **Health Care Benefits** - If the father's employer provides health care benefits, the father may be able to include the child under his health care plan.
- **Social Security** - The child may be eligible to receive Social Security benefits if the father becomes disabled or dies.
- **Inheritance** - Upon the death of the father, a child may have the right to inherit from his estate.
- **U.S. Military Benefits** - The child may be entitled to benefits as a result of the father's service in the military.
- **Child Support** - The court will order the father to pay child support until the child turns 18 or graduates from high school, whichever occurs later, unless otherwise ordered by the court. Fathers who pay child support tend to be more involved in their children's lives and children who receive child support appear to perform better in school and are less likely to become teen parents.



## Establishing Paternity for your child is in your hands



**Important Information for Unmarried Parents**

## What is paternity?

In Pennsylvania, when a child is born to a woman who is unmarried, there is no legal relationship between the father and the child unless:

- Both parents have signed a voluntary Acknowledgement of Paternity, or AOP, form;
- The father signs an Acknowledgement of Paternity/Waiver of Trial form at the county Domestic Relations Section, or DRS; or
- A county DRS or court has entered an order that establishes the legal father of the child.

**Note:** Under current Pennsylvania law, when a child is born to a married woman, the husband is the presumed legal father of the child.

## What is an Acknowledgement of Paternity, or AOP, form?

An AOP form is a free and voluntary way to establish the legal father of the child and does not require approval by the court.

## How can I get an AOP form?

- When the child is born, an unmarried mother and the father may sign an AOP form at the hospital.
- After the child is born, you can request the AOP form by contacting:
  - ◆ Your county assistance office (CAO);
  - ◆ Your county DRS; or
  - ◆ The Department of Public Welfare, Bureau of Child Support Enforcement Helpline toll-free at **1-800-932-0211**.
- If you have Internet access, visit [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us) and click on Establishing Paternity to:
  - ◆ request an AOP form; and
  - ◆ view a sample AOP form.



## What if the mother won't sign the AOP form?

A man believing he is the father of a child may make a claim of paternity by completing the child's information section, the child's birthplace information section, the mother's name, and the father's information section on the AOP form. This allows the man to be notified of certain legal proceedings concerning the child, but does not give him any parental rights. If the man feels he is the father of the child and wants parental rights, he may contact the county DRS and request genetic testing of the child.

## What is genetic testing?

Genetic testing is a procedure that identifies whether there is a biological relationship or genetic match between two people by comparing their DNA. The DNA is collected painlessly by swabbing the inside of a person's cheek. Contact your DRS for more information on scheduling a genetic test.

## What if I'm unsure that I'm the father?

Do not sign the AOP form if you're unsure that you are the father. Instead, contact your county DRS and request information about how to establish paternity.

## If I am separated from my child, does the AOP form give me custody or visitation rights?

No. Custody and visitation are separate decisions made by the courts.

## If I do not know the identity of my child's father, what should I do?

Do not sign the AOP form if you are unsure of the identity of your child's father. Instead, contact your county DRS and request information about how to establish paternity.

## I don't know where to find my child's father, what can I do?

The DRS can help you locate the father if you want to establish paternity for your child.

## What must I do if I am receiving cash assistance for my child?

If you receive cash assistance, the law states that you must cooperate in establishing paternity and obtaining a child support order, unless there is Good Cause to excuse you from doing so. Talk to your caseworker at the CAO if you have domestic violence or Good Cause concerns.

## Who do I call if I have questions?

## Be Involved

- Contact the local DRS that handles your support case with child support-related questions.
- Know what options are available to you so that you can stay actively involved in your child support case.
- Ask to modify your child support order if you are unable to pay.

## Start Now

- Paying child support leads to more involvement in your child's life.
- Family ties help to improve your ability to stay in contact with your child.
- Children who receive child support do better in school and are less likely to become teen parents or abuse drugs and alcohol.



## You Can Make A Difference

### Being A Parent While Incarcerated

Being separated from your children limits your ability to parent your children. Even though you may not be involved in the day-to-day care of your children, you can still give them support and guidance that is very important to their well-being.

### You Can Be There For Your Child...

- Pay child support for your child.
- Stay in contact with your child.
- Be involved in your child's life.

### How Can I Stay In Contact With My Child While I Am In Prison?

Contact your assigned case manager or counselor at the prison to discuss your options for staying in contact with your child.

## Pay Child Support

### Do I Still Have To Pay Child Support?

Yes, if you owe child support, then payments are still due every month. If payments are not made each month, your debt will increase.

### What Should I Do If I Cannot Pay My Child Support?

Contact the county Domestic Relations Section (DRS) that handles your support case to discuss available options. Ask for a review or modification of your child support order.

### What Is A Modification?

A modification is a change in the amount of child support you are court-ordered to pay. State law allows the court to review Pennsylvania child support orders for possible modification if you are not able to pay or are in prison. This may not apply to court orders set up in another state.

### How Will Modifying My Child Support Order Help?

If your child support amount is modified, you will have less debt upon your release from prison.

## Stay Informed

### Upon Release, Who Can I Contact If I Have Additional Questions About Child Support?

- Call or write the county DRS that handles your support case;
- Call the Pennsylvania Child Support Helpline at **1-800-932-0211**; or
- Access the Pennsylvania Child Support Web site at: [www.childsupport.state.pa.us](http://www.childsupport.state.pa.us).

### Must I Read All Mail Received From The County Domestic Relations Section?

Yes. All mail and legal notices about your child support case are important. You may be required to respond within a short timeframe. Please read all mail carefully and respond right away.

### How Can I Make Sure The DRS Knows That My Situation Has Changed?

You should write or visit (upon release) the DRS that handles your child support case to let them know right away of any changes in your situation. For example, as soon as you are released from prison you should report your address, if and where you have found a job, and/or your income.





## What does it mean to modify my support order?

To modify is to change the amount of child support you are court-ordered to pay.

## You can request to modify when you have a change in:

- Income for either party
  - ◆ New job
  - ◆ Loss of a job
- Child care expenses
- Medical coverage
- Custody
- Age of child, if your child will soon be age 18 and a high school graduate.
- Status, the person receiving support is no longer living.

## Support Order Modification



## Why Should I Ask To Modify My Support Order?

## If you are unable to pay your support and fail to modify your order, the following enforcement may occur:

- You can be incarcerated.
- The court can order financial institutions to take your assets.
- The suspension, denial, or non-renewal of the following could occur:
  - ◆ Driver's license;
  - ◆ Commercial driver's license;
  - ◆ Professional or occupational license;
  - ◆ Hunting or fishing license; or
  - ◆ Passport.
- Your Federal and State Income Tax Refunds can be taken.
- Your lottery winnings can be taken.
- Liens can be placed on property you own.
- Your Worker's Compensation and Lump Sum Personal Injury Payments can be taken.
- Your credit report can be affected.
- Your name can be placed in the newspaper.

## Who do I contact to modify my support order?

Call or write the local Domestic Relations Section that handles your support case to start the modification process.

## When can my support order be modified?

- You may ask the Domestic Relations Section (DRS) to modify your support order any time there is a change in your income.
- If you receive cash assistance, the DRS will review your support case every three years for possible modification.

## How do I modify my support order?

- Step 1:** Write, call, or visit the DRS that handles your case.
- Step 2:** Ask the DRS for a 'petition for modification' form.
- Step 3:** Review, complete, sign, and return the 'petition for modification' form.
- Step 4:** Receive notice from the DRS with the date, time, and place you are scheduled to attend\* the DRS office conference.
- Step 5:** Attend\* the DRS office conference to see if your order can be modified.
- Step 6:** If both parties agree with the new modified amount of support, the DRS will enter a new support order.

*\*If you are incarcerated and cannot attend, contact your DRS or prison case manager for instructions.*

## What if I do not agree with the recommended amount of support?

- If either party does not agree with the amount of support initially ordered, the DRS may issue a recommended support order, depending on its court process.
- A party who does not agree with the recommended support order has the right to request a hearing, which may be in front of a hearing officer or judge depending on the county court's process. Different timeframes apply to request the hearing depending on the county court's process.
- To request a hearing, call or write the local DRS that handles your support case.
